- 1. Wooden Ties are available now.
- 2. Given the deterioration of some of the concrete ties, we need to more fully understand the cause to ensure a specification that prevents a similar problem in the future.
- 3. MBCR changes more than 41,000 wood ties each year so they know how to do it very well, and they have all of the equipment needed.
- 4. Wood ties are easier to install and concrete ties are much more difficult to remove.
- 5. The wood ties being installed are technically temporary to keep speed restrictions off while concrete experts continue to search for a way to prevent problems with future potential concrete tie installations
- 6. In the absence of a solid concrete tie specification, the wood ties will remain as permanent. No final decision regarding "concrete versus wood" for the future has been reached.
- 7. Work on the Middleboro Line is first because it has experienced a greater concentration of concrete tie issues. This is a good example of the questions that are yet to be answered: why the Middleboro Line? why certain locations and not others? etc.
